Holder of the undergraduate degree becomes this candidate who studied for (8) semesters, completed his/her work placement (wherever it is required), was examined successfully on (39) number of courses - (35) number of obligatory courses and (4) number of optional ones - and submitted and defended successfully his/her Thesis. In order for a Bachelor's Degree to be awarded, 240 credit units ECTS are required.

Upon the completion of their study, the graduate has the necessary scientific knowledge in the fields of Economy and especially accounting and finance, and technological knowledge and skills to be active professionally in all areas of the Department's field, or as an executive accounting firms, organizations and services in the private and public sector, either as self-employed.

In particular, the graduate of the Department of Accounting and Finance TEI Central Macedonia has the ability to: Maintain accounting books and records of all categories according to the tax legislation and International Accounting Standards (IAS).

Prepare and analyze financial statements and detailed statements, establish businesses and organizations budgets. Apply principles and cost accounting and valuation methods, and finance and investment management, utilization of national and EU funds to finance them.

Prepare financial studies and provide financial advice.

Apply internal and external audit procedures and legislation related to accounting, tax, labor and commercial matters.

Be cognizant of modern applications of Information Science in Accounting and Finance and general Accounting Information Systems.

Interpret and analyze the accounting and financial data of enterprises and organizations in the broader domestic and international macroeconomic and microeconomic environment and prepare relevant reports and studies.

Utilize modern statistical and economic methods of study and research of issues related to accounting, organization and business management, production process, market research and their technological applications.
